Seed School - RMSA Educational courses train people from all walks of life to build resilient local seed systems rooted in the ancient tradition of seed saving. During 2018, Rocky Mountain Seed Alliance graduated a total of 247 students from its various Seed School programs: Grain School Colorado Springs, CO, 50 graduates; Seed School In A Day, Prescott, AZ, 27 graduates; Seed School In A Day, Hotchkiss, CO, 35 graduates; Seed School, Sterling College, Sterling, VT., 7 graduates; Seed School Teacher Training: Denver, CO, 23 graduates; Seed School In A Day, Albuquerque, NM, 30 graduates; Grain School In A Day, Santa Fe, NM, 25 graduates, Seed School Online Webinar, 50 graduates.

Regional Seed Network - RMSA locates, surveys, links and educates existing seed savers, seed stewards, seed producers, seed distributors, seed educators and supportive organizations in order to connect communities in the Rocky Mountain West with local seeds for a sustainable food system. In 2018, RMSA traveled throughout the U.S. and to Italy and Greece to conferences and seed events to deliver 21 presentations to more than 900 live attendees. RMSA produced and emailed 34 email newsletters to more than 3,730 subscribers, signed up 71 new seed stewards (those designating themselves as seed leaders in their community), added 95 new paid supporting members, 732 new email newsletter signups, 950 new Facebook followers and 399 Instagram followers.

Seed Conservation - RMSA promotes and educates for the establishment of community-based models of seed stewardship to prevent further loss of diversity. In 2017, RMSA continued to support the creation of new, local grain economies for our region. We continued to research and collect the seeds of grain varieties known to perform well in the Mountain West, i.e. mostly "pre-industrial, low-input, drought-tolerant, deep-root, tall-straw grains." RMSA offers up to 285 varieties. RMSA distributed small amounts of these grain seeds to a total of 92 grain trial participants, 25 new participants in 2018. The goal is to increase the number of seeds to be redistributed to new program participants the following year and finally to produce farm-size quantities of tested, adapted, heritage grain seeds available to distribute to farmers. Our online directories and order system allow participants to directly access available seeds needing to be grown out.
